## **WELCOME TO OUR PRIVACY POLICY**

YOUR PRIVACY IS CRITICALLY IMPORTANT TO US.

It is Studio MiNSK's policy to respect your privacy regarding any information we may collect while operating our website. This Privacy Policy applies to <https://studiominsk.nl/> (hereinafter, "us", "we", or "<https://studiominsk.nl/>"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the Website. We have adopted this privacy policy ("Privacy Policy") to explain what information may be collected on our Website, how we use this information, and under what circumstances we may disclose the information to third parties. This Privacy Policy applies only to information we collect through the Website and does not apply to our collection of information from other sources.

This Privacy Policy, together with the Terms and conditions posted on our Website, set forth the general rules and policies governing your use of our Website. Depending on your activities when visiting our Website, you may be required to agree to additional terms and conditions.

### **WEBSITE VISITORS**

Like most website operators, Studio MiNSK collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Studio MiNSK's purpose in collecting non-personally identifying information is to better understand how Studio MiNSK's visitors use its website. From time to time, Studio MiNSK may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website. Studio MiNSK also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on <https://studiominsk.nl/> blog posts. Studio MiNSK only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below.



## **GATHERING OF PERSONALLY-IDENTIFYING INFORMATION**

Certain visitors to Studio MiNSK's websites choose to interact with Studio MiNSK in ways that require Studio MiNSK to gather personally-identifying information. The amount and type of information that Studio MiNSK gathers depends on the nature of the interaction. For example, we ask visitors who sign up for a blog at <https://studiominsk.nl/> to provide a username and email address.

## **SECURITY**

The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.

## **ADVERTISEMENTS**

Ads appearing on our website may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognize your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. This Privacy Policy covers the use of cookies by Studio MiNSK and does not cover the use of cookies by any advertisers.

## **HTTPS://STUDIOMINSK.NL/ USES GOOGLE ADWORDS FOR REMARKETING**

<https://studiominsk.nl/> uses the remarketing services to advertise on third party websites (including Google) to previous visitors to our site. It could mean that we advertise to previous visitors who haven't completed a task on our site, for example using the contact form to make an enquiry. This could be in the form of an advertisement on the Google search results page, or a site in the Google Display Network. ## **PROTECTION OF CERTAIN PERSONALLY-IDENTIFYING INFORMATION**

Studio MiNSK discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Studio MiNSK's behalf or to provide services available at Studio MiNSK's website, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using Studio MiNSK's website, you consent to the transfer of such information to them. Studio MiNSK will not rent or sell potentially personally-identifying and personally-identifying information to anyone.

### **AGGREGATED STATISTICS**

Studio MiNSK may collect statistics about the behavior of visitors to its website. Studio MiNSK may display this information publicly or provide it to others. However, Studio MiNSK does not disclose your personally-identifying information.
